- Form B: Application for an **Exploration Licence** (exclusive);
- Form C: Application for a **Prospecting Licence** (non-exclusive);
- Form D: **Payment form** for payment of application fees.

An application shall include forms A and D and a form B or C for each licence applied for. The forms shall be filled in for all relevant sections. If the space allotted is too limited, addenda may be enclosed.
